

V-PRO CLASSIC

Structure

The court enclosure is constructed with pillars at the bottom and sides measuring 100x50, with a thickness that aligns with specified requirements. At a height of 4 meters, corners are reinforced with structural plates and feature customized trims for a polished finish.

Both the steel components and the overall structure undergo a galvanization process, and a layer of baked epoxy polyester resin is applied for added protection and durability.

Paint

The metallic elements are coated with a thermosetting polyester powder paint formulated with polyester resins. This QUALICOAT certified finish, in the customer's desired color, provides these elements with excellent resistance to corrosion and ultraviolet rays, as well as high resistance to mechanical impacts.

In coastal and salty environments, we treat the structure with an additional two-coat primer system of pure epoxy, which is coated with either a powder or liquid finish.

Glass

Certified 10mm tempered glass is installed on 5mm neoprene to minimize vibrations and reduce the risk of breakage. The manufacturing process for all these tempered glasses follows a standardized production procedure in accordance with the UNE EN 12150-1 standard.

Structure

The court enclosure is comprised of a self-supporting structure featuring structural tubes, enclosed, and anchored with two upper and lower perimeter rings. The upper ring is constructed of structural tube, while the lower ring is made of structural plate.

Both the galvanized steel and the structure are coated with baked epoxy polyester resin for added durability and protection.

The galvanized electro-welded mesh, with dimensions of 50x50x4mm, is delivered without projections. Frames are formed with structural plates of thickness according to specifications. Additionally, there are two horizontal pipe cross pieces designed to prevent buckling, ensuring the structure maintains its integrity under weight.

Paint

The metallic elements are coated with a thermosetting polyester powder paint formulated with polyester resins. This QUALICOAT certified finish, in the customer's desired color, provides these elements with excellent resistance to corrosion and ultraviolet rays, as well as high resistance to mechanical impacts.

In coastal and salty environments, we treat the structure with an additional two-coat primer system of pure epoxy, which is coated with either a powder or liquid finish.

Glass

Approved 12mm tempered glass is used for the panoramic backdrops and side windows. For the side windows, the court has two large windows, each measuring 2x3m, identical in size to the backdrops or the traditional system. All are installed on 5mm neoprene to minimise vibrations and the risk of breakage.

The manufacturing process for all this tempered glass follows a standardised production process and complies with the UNE EN 12150-1 standard.


